



## HMG OUTCOMES MATTER

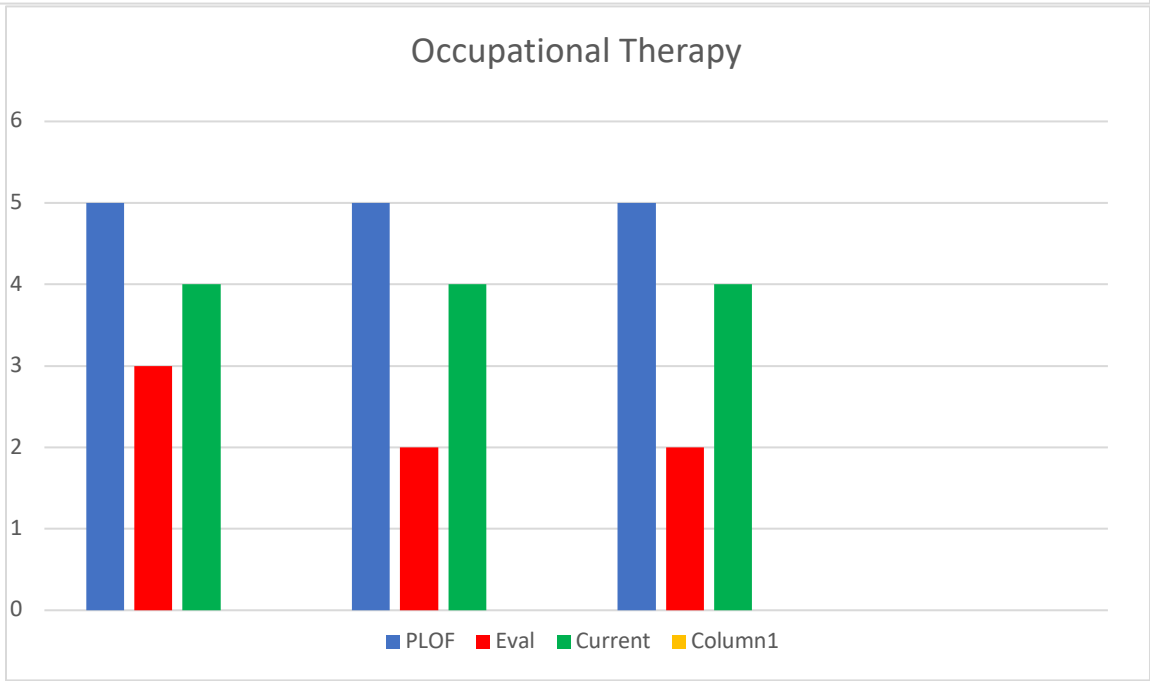
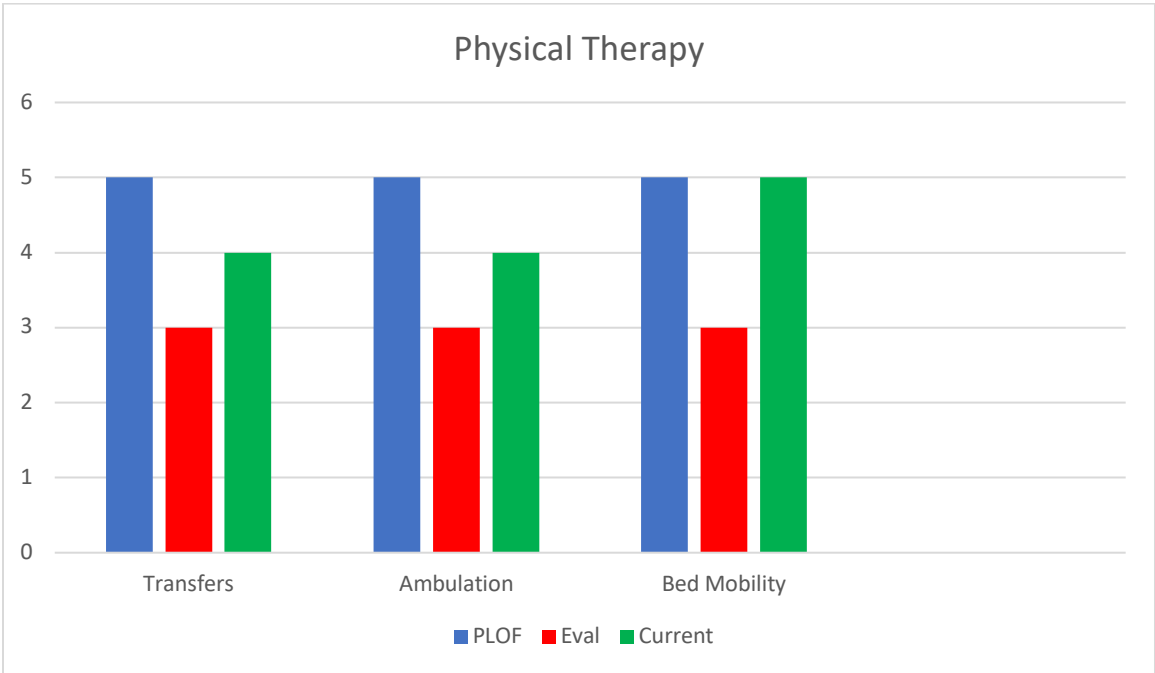
Mr. Ricardo Martinez is a 78-year-old male who admitted to Crowley Nursing and Rehab on 6/19/24 following acute hospitalization for acute metabolic encephalopathy and acute kidney injury. These medical complications effected his ability to return back to prior living environment from the hospital. Prior to hospital stay, Mr. Martinez was living at an ALF and completed ADLs and ambulation of 300' at MODIFIED INDEPENDENCE LEVEL. When Ricardo admitted to this SNF, he required min-max assistance for mobility and daily living tasks. Mr. Martinez set a personal goal of improving his functional level of independence to improve his quality of life.

Physical Therapy evaluated Mr. Martinez on 6/20/24 where he required MIN-A for bed mobility, transfers, and ambulation of 25' using a 2WW. Ricardo had moderately impaired balance and leg strength and was a high risk for falls. PT set goals for Mr. Martinez to improve his strength, balance, ambulation, bed mobility, and transfers.

Occupational Therapy evaluated Ricardo on 6/20/24 where he required MOD-A for ADLs and MAX-A for toileting and lower body dressing. Mr. Martinez had impaired upper extremity strength and standing balance for ADL completion. OT set goals for the patient to improve his ability to complete ADLs, lower body dressing, toileting, standing balance, and upper body strength.

Mr. Ricardo Martinez received 26 days of skilled nursing and rehab services where he made significant functional improvements. At DC from skilled PT and OT services, Ricardo was able to ambulate 200' using a 2WW with CONTACT GUARD ASSISTANCE, complete bed mobility and transfers with STANDBY ASSISTANCE, and ADLs, LB dressing, and toileting with MIN-A. Mr. Martinez met his personal goal of improving his physical function for increased independence and quality of life.





## MDS Section GG Functional Scores

### **06 Independent**

Completes the activity by him/herself with no assistance from a helper

### **05- Setup or clean-up assistance**

Helper sets up or cleans up; patient completes activity. Helper assists only prior to or following the activity.

### **04 - Supervision or touching assistance**

Helper provides verbal cues and/or touching/steadying and/or contact guard

assistance as patient completes activity. Assistance may be provided throughout the activity or intermittently.

### **03 - Partial/moderate assistance**

Helper does LESS THAN HALF the effort. Helper lifts, holds, or supports trunk or limbs but provides less than half the effort.

### **02 - Substantial/maximal assistance**

Helper does MORE THAN HALF the effort. Helper lifts or holds trunk

or limbs and provides more than half the effort.

### **01 - Dependent**

Helper does ALL the effort. Patient does none of the effort to

complete the activity. Or the assistance of 2 or more helpers is required for the patient to complete the activity.
